"A study from the Barna Group revealed that **half of US pastors 'feel worried about speaking out** on certain issues because they're worried about offending people,' particularly people in their own churches. The survey says the **pastors feel 'limited' to speak when it comes to issues of gay 'marriage'** (22%) and homosexuality and transgender (44%). ... Starting with Genesis, we can say marriage is for one man and one woman because God created marriage when he created the first male and female, Adam and Eve (Genesis 1:27; 2:24)—which deals with the gender issue.
